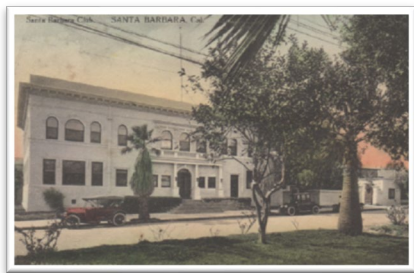




PRESERVING HISTORY
